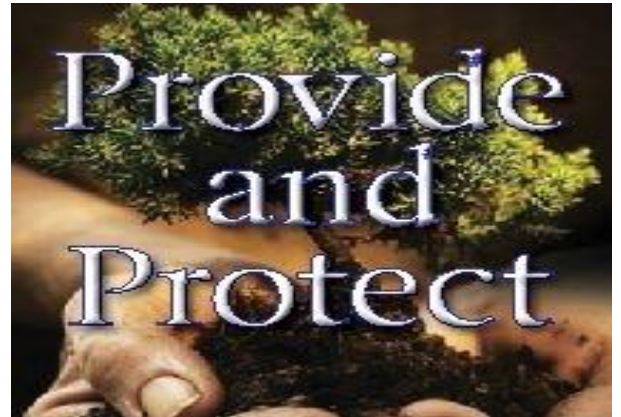

### Obamas and Bidens Publish 2014 Tax Returns

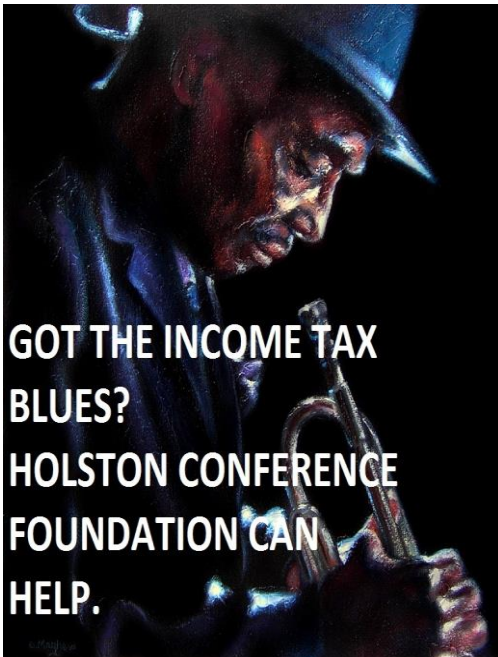
