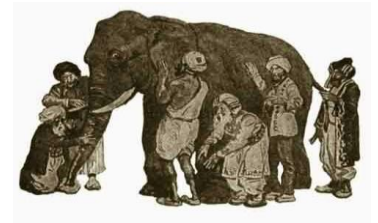

WHAT CAN THE FOUNDATION DO FOR YOUR LOCAL CHURCH?

Do you know the story of the elephant and the blind men that originated in India? Several blind men come across an elephant and began to touch it. The blind man who feels a leg says the elephant is like a pillar; the one who feels the tail says the elephant is like a rope; the one who feels the trunk says the elephant is like a tree branch and so forth.

As each man felt a different part of the elephant they came to totally different conclusions. Churches and individuals often have the same experience as the blind men. In order to give the greater picture of how the Foundation can help your church, consider the following services provided by the Foundation:

- **Stewarding God's resources**-The Foundation offers expert investment management of church endowments and designated funds and can serve as trustee of charitable trusts and other planned gifts. By following a carefully crafted investment policy, the Foundation offers a broad-based set of investment options for the local church.
- **Resourcing the local church**-The Foundation provides customized printed resources that churches utilize in promoting endowment and planned giving options, as well as information on financial stewardship.
- **Speaking**-Foundation staff frequently speaks and preaches at church events, including Sunday services, leadership/committee meetings, United Methodist Men/Women's events, Sunday Schools, and provides estate planning seminars.
- **Advising individual donors**-Individuals contemplating significant gifts or bequests frequently visit with their pastor or their professional advisor for information and advice. The Foundation's professional staff can counsel the individual or provide the appropriate advisor with information.
- **Serving as a consultant to a committee**-We counsel churches in establishing a wills and legacies task force or endowment committee. We work with committees on strategically promoting planned gifts to the congregation.
- **Funding ministry**-The Holston Conference Foundation stewards nearly 200 special-purpose endowments and scholarships established by individuals, families, and friends interested in supporting specific ministries, churches, and institutions. Sometimes donors create funds that support a broader purpose or where a choice has to be made and our grant committee reviews and awards funds based on a signed local agreement.
